## Terms of Agreement

Upon signing and returning this contract to the contractor the client agrees to include a **\$400** non-refundable, date saving deposit. Said deposit will be applied to the total balance due. The contractor **must** receive the remainder of the total balance for the event no later than one week prior to the event. Payment **must** be made in cash or money order. Should the date or location of the event change for any reason, proper written notice and consideration should be given to contractor. Contractor reserves the right to ask for financial consideration, should such changes be requested by client (ie: further travel, longer hours, or any other request deemed by the contractor as beyond original requested services). A mileage charge of \$2.00 per mile one way applies to all events outside 50 miles of Cuba City, WI or 20 Miles outside of Davenport, IA unless agreed upon. (Exact miles are determined using Google Maps by DJ)

Client agrees to provide adequate shelter (when event is outdoors), Qty. 2 – 20 Amp Circuits (minimum), Qty. 1 6'-8' Table, and other material deemed necessary by contractor.

When contractor receives this contract fully completed and including the deposit your date will be saved. The contract will then be reviewed and if no discrepancies are found will be signed and a copy will be sent back to you for your records. Failure to comply with the "Terms of Agreement" can result in termination of contract along with the forfeit of deposit and services.
